TRAINER CODE OF CONDUCT

You, the trainer, have read this Code of Conduct (the "Code") and agree to be bound by it. The consequences for any Code violations may result in fines and/or removal from training for Albertson Soccer Club ("ASC").

- 1. Trainers shall abide by all current policies in effect by ASC and PRSS.
- 2. As outlined in the training schedule established at the beginning of each season, trainers are to arrive at least five (5) minutes prior to each scheduled training session and thirty (30) minutes prior to each assigned game. The thirty (30) minute requirement does not apply if the trainer is traveling from one (1) game location to another but will do their best to arrive as early as possible.
- 3. If a trainer cannot attend their assigned game due to a known conflict, the trainer must inform either ASC Executive Board or Paul Riley Soccer School ("PRSS") at least 24 hours prior to the game (excluding emergency situations where notification shall be provided as soon as practical).
- 4. During all training sessions, a trainer's undivided attention to the players is mandatory. No talking to parents and/or cell phone usage is permitted during training sessions (unless in an emergency situation).
- 5. During a game, in any situation whereby a trainer receives a "Red Card" and is ejected from the game, the trainer is to immediately leave the field and then inform both the ASC Registrar & ASC President. Trainer should be ready and able to provide a report detailing the events which led to the Red Card issuance.
- 6. At no time is a trainer to engage in a physical altercation before, during or after a training session or game.
- 7. If at any time there is a problem with a field (due to availability, weather or otherwise), the trainer is to contact the ASC designated field coordinator <u>or</u> an ASC Board Member. At no time is a trainer to train or play with ASC players on a field that where ASC does not possess a permit.
- 8. A trainer is to come properly dressed for all training sessions and games.
- 9. At no time is a trainer to have private training sessions with any ASC player(s) on their team <u>or</u> any team in the same age group. If a parent approaches a trainer for private training, the trainer shall advise them to contact PRSS (Paul Riley or Kevin Koehn).
- 10. At no time is a trainer to enter an ASC team or use any ASC players in a League and/or Tournament without prior approval from PRSS or an ASC Executive Board Member. Moreover, at no time is a trainer to request an ASC Manager to enter a team or use any ASC players in a League and/or Tournament without prior approval from PRSS or an ASC Executive Board Member.
- 11. Trainers shall read the ASC Travel Per Diem Policy and abide by its terms. Trainers are prohibited from taking any additional compensation from a Manager or a team

- player/parent without making appropriate repayment arrangements or a written statement that the funds given are not to be paid back.
- 12. Trainers are prohibited from sending e-mails or texting players. However, at the age groups U15 and older, trainers may communicate directly with players, including sending e-mails and texts, for the purpose of assisting/communicating with college contacts on a player's behalf.
